- Grant of stock under the Issuer's 2011 Equity Incentive Plan, as amended, in connection with the Reporting Person's services as a Director.
- The aggregate dollar value of the annual equity award to each director in 2017-2018 shall be \$220,000, with one quarter of that amount in stock, or \$55,000, to be granted on the first day of each quarter based on the closing price of the Issuer's common stock on such day. Since the grant date of October 1, 2017 was a non-trading day, the number of shares was calculated based on the closing price of the Issuer's common stock on September 29, 2017, of \$68.76. Thus, the grant this quarter for services as a Director is for 800 shares of the Issuer's common stock.
- Represents the closing price of the Issuer's common stock on September 29, 2017.
- Shares are held by The F E M & I L M Revocable Living Trust.
