- 3,500 shares vest in one-quarter increments on each of 3/1/08, 3/1/09, 3/1/10, and 3/1/11. 3,500 of the shares are subject to a restriction on transfer until August 2, 2007. The remainder of the shares are fully vested.
- The options vest one-third on each of 2/10/2005, 2/10/2006, and 2/10/2007.
- The options became fully exercisable upon the closing of the initial public offering of the issuer in July 2003.
- The options vest one-third on each of 7/1/2006, 7/1/2007, and 7/1/2008.
- The options vest one-third on each of 2/2/2007, 2/2/2008, and 2/2/2009.
- The options vest in one-quarter increments on each of 3/1/08, 3/1/09, 3/1/10, and 3/1/11.
