- Shares issued in settlement of performance stock units granted in 2018 which vested at the 200% max level based on the achievement of cumulative net income metric over the three fiscal years of 2018, 2019, and 2020.
- Shares were applied to payment of withholding taxes in connection with vesting of the above-mentioned performance stock units.
- Shares shall vest as follows: the 6,300 newly granted shares vest in one-third increments on each of March 1, 2022, March 1, 2023, and March 1, 2024. Additional shares shall vest as follows: 4,646 on March 1, 2022; 2,720 on March 1, 2023, and 2,939 on January 10, 2022. The remaining shares are vested.
